

#### COVID-19 Risk Assessment for 2023-24

#### Introduction

Our core obligation remains to ensure "so far as is reasonably practicable the health, safety and welfare of employees and the safety of non-employees" remains as does the obligation to risk assess and implement relevant control measures where the risk concerned cannot be mitigated.

On Monday 21 February, the Prime Minister set out the next phase of the government's COVID-19 response <u>'Living with COVID-19'</u>. COVID-19 continues to be a virus that we learn to live with and the imperative to reduce the disruption to children and young people's education remains.

All employers are required by law to protect their employees, and others, from harm. Under the Management of Health and Safety at Work Regulations 1999, the minimum employers must do is:

- Identify what could cause injury or illness in the organisation (hazards)
- Decide how likely it is that someone could be harmed and how seriously (the risk)
- Take action to eliminate the hazard, or if this isn't possible, control the risk
